RESOLUTION NO. <u>1724</u> Series of 2023

RESCHEDULING THE NOVEMBER 2023 CHEMISTS AND CHEMICAL TECHNICIANS LICENSURE EXAMINATIONS TO DECEMBER 13 & 14, 2023 AND DECEMBER 15, 2023, RESPECTIVELY, EXTENDING THE DEADLINE OF APPLICATION PERIOD, AND FIXING THE TARGET DATE OF RELEASE OF EXAMINATION RESULTS

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1589 (s. 2022) scheduling the Chemical Technicians Licensure Examination (CTLE) on October 29, 2023 and Chemists Licensure Examination (CLE) on October 30 & 31, 2023 in various testing centers nationwide;

WHEREAS, by virtue of the Supreme Court ruling, the election for Barangay and Sangguniang Kabataan was set on the last Monday of October 2023;

WHEREAS, the Commission issued Resolution No. 1689 (s. 2023) rescheduling the October 2023 CLE and CTLE to November 25 & 26, 2023 and November 27, 2023, respectively;

WHEREAS, the Professional Regulatory Board of Chemistry (Board) received requests from examinees to reschedule the said licensure examinations on weekdays;

WHEREAS, the Board and the Licensure Office recommend the rescheduling of the affected licensure examinations during weekdays in December 2023;

WHEREFORE, the Commission RESOLVES, as it is hereby RESOLVED, to RESCHEDULE the CHEMISTS LICENSURE EXAMINATIONS and CHEMICAL TECHNICIANS LICENSURE EXAMINATIONS, EXTEND the Deadline for Filing of Applications, and FIX the Target Date of Release of Examination Results of the said licensure examinations, as follows:
